

One Central Macau Parking Terms and Conditions:

- The One Central Macau complimentary parking privilege will be effective from 1st January to 30th June, 2023.
- 2. Same-day original receipt(s) issued by shops at One Central Macau or MGM Macau (applicable to Spa & F&B outlets in MGM Macau only, not applicable to participants of any event or banquet in MGM Macau) must be presented.
- 3. Guest cannot be combined this privilege with other offers under the below circumstances:
 - a. If guest spends any amount at One Central Macau retailers (amount less than MOP500), two F&B outlets at MGM Macau or spends any amount at one F&B outlet and SPA at MGM Macau, guest is ONLY entitled for 3-hour free parking on the same day. Guest can only enjoy maximum 3-hour free parking privileges even in conjunction with more than ONE receipt;
 - b. If guest spends any amount at one F&B outlet or SPA at MGM Macau whilst guest also attends the banquet at MGM Macau on the same day, he/she can ONLY either enjoy the 3-hour free parking by spending any amount at F&B outlet/SPA of MGM Macau or enjoy the 3-hour banquet privilege (specially granted by MGM banquet team). Guest can only enjoy maximum 3-hour free parking privileges even in conjunction with more than ONE receipt;
 - c. If guest spends more than MOP500 with single receipt at one of the shops at One Central Macau whilst guest spends any amount at F&B outlet or SPA at MGM Macau on the same day, he/she can ONLY be entitled for 5-hour free parking on the same day. Guest can only enjoy maximum 5-hour free parking privileges even in conjunction with more than ONE receipt;
 - d. If guest spends more than one transaction at the shops of One Central Macau whilst one of the transactions is over MOP500, he/she can ONLY be entitled for 5-hour free parking on the same day. Guest can only enjoy maximum 5-hour free parking privileges even in conjunction with more than ONE receipt etc.
- 4. Receipt(s) which is/are outdated, damaged, altered and/or hand written will not be accepted. Receipts from internet purchases, mail orders, phone orders, charity donations, bank transactions, exchanges/refunds, purchase of gift voucher and/or cash vouchers, bill-payments and/or credit card payments will not be accepted.
- 5. Only duplicated and reprinted receipt(s) issued by participating F&B outlets at MGM Macau with authorisation will be accepted for redemption, other duplicated and reprinted receipt(s) will not be accepted.



- 6. No receipt is allowed to be re-used in this promotion. Each receipt can only be redeemed once.
- For every additional hour beyond the complimentary period, the prevailing parking fee will be duly charged onwards.
- Redeemed offers cannot be returned and exchanged for cash, discounts or other products. All
 unused complimentary parking hours cannot be returned and exchanged for cash, discounts or
 other products.
- 9. The operating hours for One Central Macau and 2F service counter is 10:30am 12:00am daily; this privilege can only be used during the operating hours (This carpark privilege is not applicable to non-operating hours). All redemption must be registered at One Central Macau service counter on 2F in person before 12:00am.
- 10. This privilege can only be used for self-parking service at One Central Macau. Please visit the service counter on 2F to have the parking ticket stamped before leaving One Central Macau Car Park.
- 11. There are 15 minutes for the car owner to exit the car park after the parking ticket is stamped.

 Parking fees will be charged in accordance to the exceeded time.
- 12. All commercial vehicles, working personnel (including sales personnel, staff, contractors of any occupants of any unit in or retailers of One Central Macau) are NOT eligible to participate in the complimentary parking promotion.
- 13. Properties Sub F, Limited reserves the right to stop offering the complimentary parking privileges if the commercial vehicles, working personnel (including sales personnel, staff, contractors of any occupants of any unit in or retailers of One Central Macau), staff of MGM Macau and Mandarin Oriental, Macau are abuse of the carpark privilege. This issue will also be escalated to the relevant department for investigation.
- 14. Properties Sub F, Limited reserves the right to amend the offer, terms and conditions and/or withdraw the complimentary parking promotion at any time without any prior notice. In case of any dispute, the decision of Properties of Sub F, shall be final and binding on all parties concerned. Properties Sub F, Limited and One Central Macau reserve the rights to determine and arbitrate for final decision on any dispute on the complimentary parking promotion.
- 15. Car park regulations apply.
- 16. Parking of vehicles in this car park is entirely at the sole risk of the vehicle owner and driver.

 Neither the car park owner nor the manager shall assume any responsibility or liability for any loss or damage to any vehicle or its contents in the car park.
- 17. A 24-hour parking charge at the prevailing hourly rate and an administration fee of MOP 100 will be charged to any car park user who is unable to produce a valid car park ticket, regardless



of the actual no. of parking hours.

- 18. All parties redeeming for this complimentary parking and/or using the car park of One Central Macau must fully observe, perform and comply with the terms and conditions above and the car park regulations as may be prescribed and/or amended by Properties Sub F, Limited and/or Hongkong Land (One Central) Retail Property Management Limited from time to time.
